Dear Mr. Gill,

Due to failure to comply with the requirements of Title 159 Chapter 7, Chapter 5 and Chapter 13, tanks 07 and 08 of your facility are hereby subject to delivery prohibition. Title 159 specifies Underground Storage Tank (UST) systems may be subject to delivery prohibition as a result of non-compliance with Leak Detection Requirements of Chapter 7. (Title 159 001.01B) Overfill Requirements Chapter 5. (Title 159 Chapter 5 001.01D) Operator Training Requirements of Chapter 13. (Title 159 Chapter 13 001.01F) Lawful orders were issued to correct the above items on December 16, 2024, January 30, 2025 and March 28, 2025, during which time none of these items have been resolved.

The following list applies to UST systems subject to delivery prohibition:

- A. No owner or operator may deposit or accept the deposit of any regulated substance into an UST system that has been designated as ineligible for fuel deliveries by the application of a red tag. TITLE 159 11-002.01
- B. No product deliverer or other person may deliver or deposit any regulated substance into an UST system that has been designated as ineligible for fuel deliveries by the application of a red tag. TITLE 159 11-002.02
- C. No person other than the State Fire Marshal shall remove a red tag from an UST system without prior approval. TITLE 159 11-003.01



D. The State Fire Marshal shall verify compliance within two (2) business days of receiving a communication from the owner or operator that the corrections have been made. If the UST system is found to be eligible for delivery, the State Fire Marshal shall remove the red tag. As soon as practicable, but no more than three (3) business days after removal of the red tag, the facility shall be removed from the State Fire Marshal website list of sites ineligible for delivery. TITLE 159 11-003.02

In order to resume receiving fuel deliveries, please correct the violations as outlined on the attached order form and associated comments sheet. We look forward to resolving these items with you as quickly as possible.



Revisit Inspection #3

The following violations at this facility shall be corrected within 90 Days of this inspection:

1. Dispenser 1/2. Breakaways and swivels need to be replaced due to surpassing manufactures "remove by date".
2. Dispenser 1. Nozzle needs to be replaced due to surpassing manufactures "remove by date".
3. Dispenser 2. Long hose needs to be replaced due to damage.
4. Dispenser 1/2. There is evidence of a fuel leak from the upper portion of dispenser 2. Dispenser to remain out of use until repaired.
5. Dispenser 3/4. Both hose are required to swivel installed.
6. Dispenser 3. Replace long hose due to damage.
7. Dispenser 3. Nozzle needs to be replaced due to surpassing manufactures "remove by date".
8. No inventory available. Daily Inventory shall be made available upon inspection.
9. No ATG annual inspection. All three annual Automatic Tank Gauge inspections shall be made available upon inspection.
10. Facility needs spill buckets tightness tested. Last three test results are to be on site for three years.
11. Facility needs to provide a current and or up to date overfill protection test. Last 3 test results are to be on site for three years.
12. Facility is required to do monthly and annual walkthrough inspections on spill prevention and release detection equipment. Monthly walkthrough and annual walkthrough inspection shall be kept at the facility for a 3 year time period.

Due to uncorrected violations this facility will be in "Red-Tagged Prohibition" prohibiting delivery to tank(s) 07 & 08. This is in accordance with **TITLE 159 CH 11, 001.01**.

16. Within the next 90 days of this inspection, this facility shall have the listed violations corrected. Uncorrected violations will remain in "Red-Tagged Prohibition" status prohibiting delivery to tank(s) 07 & 08. This is in accordance with **TITLE 159 CH 11, 001.01**.

001.01A. Tank registration requirements of Chapter 2;



20. Do not remove red tag from any tank fill pipe until **ALL ITEMS ARE** completed. Facility will be revisited periodically.
21. If work is to be done, DSFM Wiese is the only authorized person to remove red-tags, unless otherwise directed by Chief Levering to authorize replacement personnel.
