## One Time Registration Underground Storage Tanks

Nebraska statutes require a one time registration of certain underground storage tanks which are exempt under the Federal notification program. Use this form for tanks required to be registered under <u>Neb. Rev. Stat</u> Section 81-15,120 and 81-15,121. For Heating Oil Tanks Over 1,100 gallons, use Form FLST.19 (Rev 12/92). For registration of federally regulated tanks use EPA Form 7530-1 (Rev 4/97).

Mark the box indicating the kind of tank you are registering. If a farm or residential motor fuel tank or heating oil tank was permanently abandoned as of January 1, 1974, mark Section C only. Use a separate form if you are registering more than one type of tank.

## Definitions

**Farm Tank** shall mean a tank which is (1) located on a tract of land devoted to the production of crops or raising animals, including fish, and associated residences and improvements, (2) of one thousand one hundred (1,100) gallons or less capacity, and (3) used for storing motor fuel for consumptive use on the premises where stored.

**Residential Tank** shall mean a tank which is (1) located on property primarily used for dwelling purposes, (2) of one thousand one hundred gallons or less capacity, and (3) used for storing motor fuel for consumptive use on the premises where stored.

**Small Heating Oil Tank** shall mean a tank (1) of one thousand one hundred (1,100) gallons or less capacity, and (2) is used to store heating oil for consumptive use on the premises where stored.

**Permanently Abandoned Tank** shall mean a tank that was taken permanently out of service prior to January 1, 1974 as a storage vessel for any reason.

Please note: Removal of a tank registered as permanently abandoned tank must comply with Title 159 Nebraska Fire Marshal Rules and Regulations Underground Storage Tanks, which include the requirements of a closure permit. For Farm or Residential and Small Heating Oil Tanks, the owner will only need to notify the Fire Marshal's Office when the tank is removed.
