3.	Permission to burn will be granted ONLY to the chief of the local fire department and only AFTER written application is APPROVED by the State Fire Marshal in writing.							
4.	Permit to Burn must be in the hands of the local fire chief before burning exercise is conducted.							
5.	Fire Department and/or owner shall assume all liability for damage which might occur due to this burning exercise.							
6.	Do not burn if it is windy or property to be burned is close to another person's building.							
7.	Fire chief and firefighters, before departing from fire scene, SHALL and MUST extinguish ALL embers very thoroughly to prevent rekindling.
