- Alternatively, testing is offered at Fire School in Grand Island. 2020 Fire School will be held on May 15th, 16th, and 17th. Testing will take place **May 15 and May 17 between 7:00 A.M. and 4:00 P.M.** Please check in at the State Fire Marshal booth in the vendor building. If you wish to take the test at Fire School, you must submit the application and citizen attestation form to the Lincoln office no later than **May 8, 2020**.
- Tests are **NOT** open book, but there is no time limit to complete the exam.
- There is no charge for the license.
- All cell phones must be off and in a pocket, purse, phone holder, etc. until you leave the testing area. Any phone that is not turned off will constitute automatic failure of the exam, and the applicant may be dismissed from testing.
- An applicant who fails the exam may apply to retake the exam after ten days.
- Exam questions will be multiple choice and true/false.
- The following information is considered appropriate exam preparation material:
 - Title 157, Chapter 3 of the Nebraska Administrative Code*

To create the fire alarm and display operator's schedule for the upcoming year, open a new copy of the template, and edit the dates/locations as needed for each type of exam. Instructional text should not need to be edited (updated 2018).

Notes about font size/spacing.

- All text is Franklin Gothic Book.
- Header is 14pt bold in Blue, Accent 5, darker 50%.
- Special accommodation line is 11pt font, italics
- Test time/ID line is 11pt font, bold, all caps.
- Column headers are 11pt, bold font.
- Text body is 9pt Franklin Gothic Book.
- Document spacing is single-spaced, with space before and after paragraph removed.

Borders:

- Borders are drawn around the Application Deadline, Test Date, etc. (column headers) and the subsequent lines of data in the chart.
- Borders are top and bottom, straight line, ½ pt. width

Tests are scheduled at the NSOB March – June, as it is likely to be the peak of the season, and with more testers registered, more room will be needed. **DO NOT VARY THESE MONTHS.**
