- Tests may also be taken during Fire School in Grand Island at Fonner Park. Fire School 2021 will be held May 21, 22, and 23. Please check in at the State Fire Marshal vendor booth in the vendor building on one of these days. If you would like to take the test at Fire School, you must submit the application and citizen attestation form to the Lincoln office no later than **May 14, 2021**.
- Tests are **NOT** open book, and there is no time limit to complete the exam.
- There is no charge for the license.
- All cell phones must be off and in a pocket, purse, phone holder, etc. until you leave the testing area. Any phone that is not turned off and secured will constitute an applicant's automatic dismissal and failure of the exam.
- The following information is considered appropriate exam preparation material:
 - **STUDY MATERIAL:** NFPA 1123 (2010), NFPA 1124 (2006) and state statute 28-1241. NFPA Codes can be purchased or viewed for free at www.nfpa.org.
