IQS Number*: Due to the rise in identity theft, your social security number is no longer used for identification in the Nebraska IQS. The replacement number is your first initial followed by the first four letters of your last name and the last four numbers of your social security number. For example, if John Q. Public has a social security number of 123-45-6789, his IQS number would be jpubl6789. If your last name has just three letters, use the first two letters of your first name. This information will be released to the federal government when the information in the database is exported for training validation and establishing a personal portfolio of each fire fighter.

Type* - Enter type of experience - JOB, OJT or TRN. See page two for descriptions.

Qual* - Enter the appropriate NWCG four letter identifier for the position that the firefighter is claiming experience. See page two for list of identifiers. Equivalency qualification is only available for Firefighter Type 2 (FFT2), Firefighter Type 1 (FFT1), Engine Boss (ENGB) and Crew Boss (CRWB).

Risk* - Enter risk type (wildland fire, all risk, etc.). List is on page two. Most firefighters will enter WF (Wildfire) in this column.

Incident No. - Enter incident number (federal, local) if available.

Incident Name - Enter incident name (ex: Sioux County Complex). If fire is unnamed, enter a geographic reference (ex: Chimney Rock).

Date(s)* - Enter dates the firefighter was active on the incident.

OP* - Enter number of operational periods the firefighter took action on the incident. An operational period is the period of time scheduled for execution of a given set of tactical actions. Operational periods can be of various lengths, but are typically 12-16 hours and usually not over 24 hours. For fires of less than 12 hours, count as one operational period. For example, a fire starts on July 8th and burns for four days. The firefighter spends 22 hours on the fireline the first day, 12 hours on day two, 12 hours on day three and 6 hours on day four. This would constitute four operational periods.

Eval - If the Incident Commander or your fireline supervisor provided an evaluation, enter the result here. This primarily occurs on incidents operated under the command of federal resources. If an evaluation is not offered, fire personnel may request one. See page two for options.

Quality - What was the quality of the assignment with regard to improving your experience? Good? Fair? Poor?

Comments (incident hours) - Add any additional information. Please also include an estimate of the number of hours spent on the fireline.
