- Tests may also be taken at Fire School in Grand Island. Fire School 2019 will be held on May 17, 18, and 19. **Testing will take place May 17 and May 18 between 7:00 A.M. and 4:00 P.M.** Please check in at the State Fire Marshal booth in the vendor building. If you would like to take the test at Fire School, you must submit the application and citizen attestation form to the Lincoln office no later than **May 9, 2019**.
- Tests are NOT open book, but there is no time limit to complete the exam.
- There is no charge to obtain a license, which is valid for three years.
- All cell phones must be off and in a pocket, purse, phone holder, etc. until you leave the testing area. Any phone that is not silenced and out of sight will constitute automatic failure of the exam, and the applicant may be dismissed from testing.
- An applicant who has failed the first test may apply to retake the exam a second time after ten days.
- If an applicant fails their second exam, they may apply to retake it **six months** after the date of their *FIRST* attempt.
- The exam will consist of a variety of multiple choice and true/false questions.
