This year's Fire School will be held on May 15, 16 and 17, 2015 and testing will take place May 15th and 16th between the hours of 8:00 a.m. and 5:00 p.m. on both days. If you would like to take the test at Fire School you must submit the application and citizen attestation form to the Lincoln office no later than Friday May 7th, 2015.
- ◆ Tests are **NOT** open book.
- ◆ There is no charge for the license.
- ◆ An applicant who has failed the exam may apply to retake the Exam after ten days.
- ◆ Exam will be multiple choice and true/false.
